To aid conservation planning and decision-making, for example by understanding species' representativeness and complementarity across conservation areas, we can combine species' range estimates across multiple species groups to calculate community-level metrics of conservation interest that reflect different dimensions of biological diversity such as species richness, spatial and temporal turnover, endemism, and phylogenetic diversity. We provide an example below to calculate these metrics for a dataset of Colombian primates (Henao-Díaz et al. 2020) using the 'changeRangeR' package. For information on single species range change metrics, see the single-species vignette .

Species Richness

Here we measure species richness as the number species predicted to be present in each pixel.

Load and manage spatial data

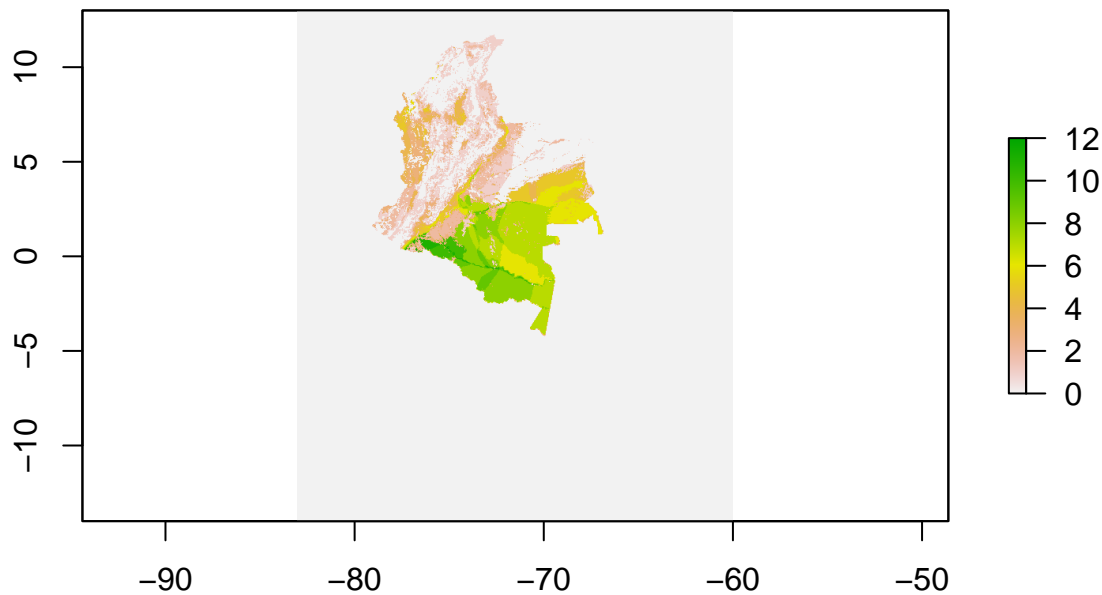
Loading the SDM data and ensuring the names match the phylogeny, and removing some resolved species.
NOTE: For calculating species richness, named rasters are not strictly necessary.

Phylogenetic diversity

Phylogenetic diversity can be calculated from binary range-maps, or as here, thresholded SDMs. We combine these maps with phylogenetic trees to calculate this measure of diversity. Here, we calculate phylogenetic diversity as the sum of branch lengths using Faith's PD (Faith, 1992).

It is important to note that species-experts can edit binary SDMs, such as is done in the R package *maskRangeR* to add or remove areas.

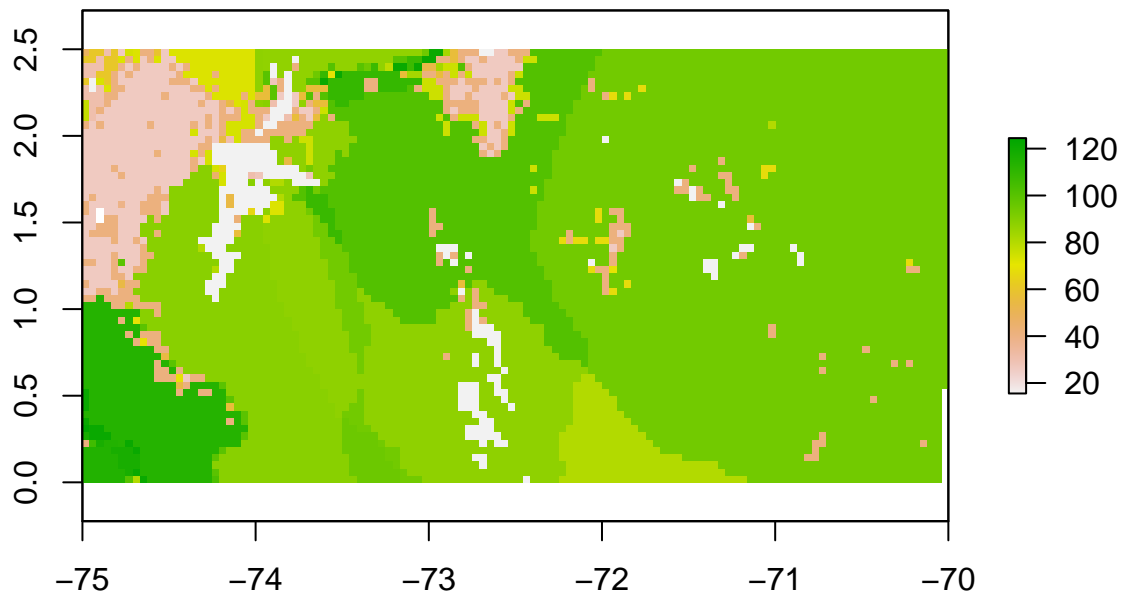

Phylogenetic endemism Phylogenetic endemism combines phylogenetic trees with spatial data. PE is calculated by dividing each branch length over the total number of locations where the species that descend from that branch are found (Rosauer et al., 2009).

Here, we can calculate PE from a function written by, and hosted by Dan Rosauer on Github

To begin, load and manage the spatial data to make sure the names match those in the phylogeny

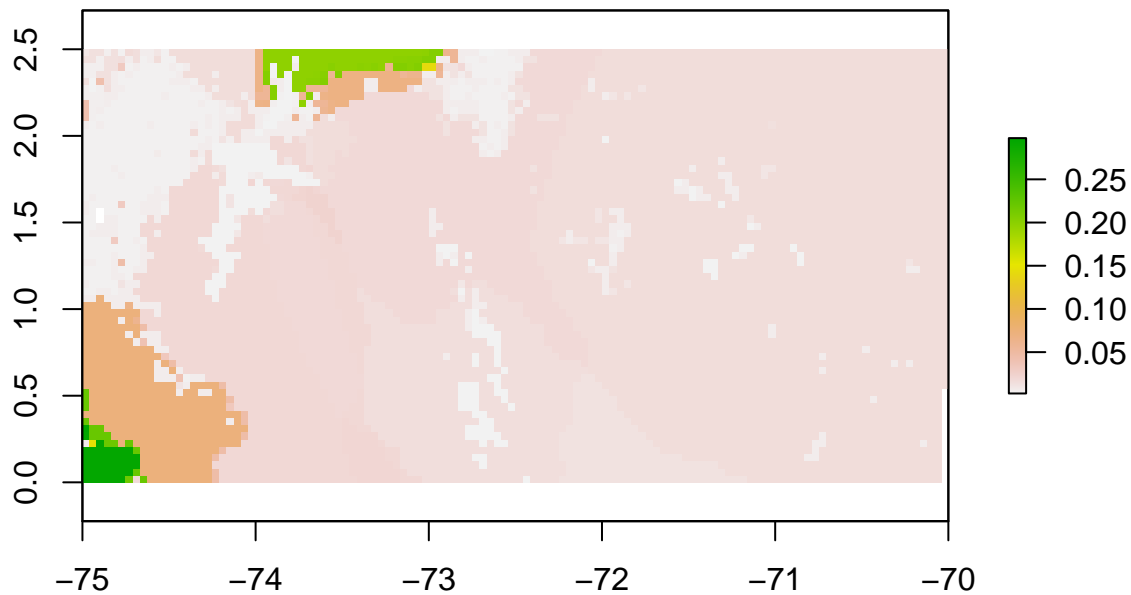

Species Endemism

Here, species endemism is defined as a value for each cell equal to the number of species found in that cell divided by the total number of cells in which they are found

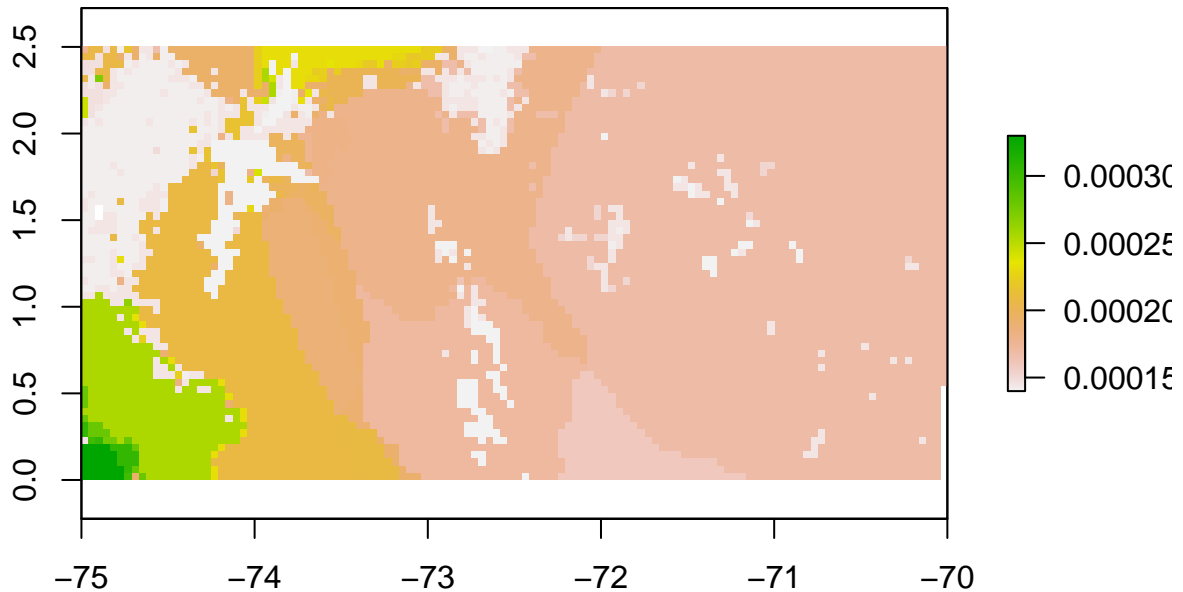

Complementarity

It is often useful to spatially quantify biodiversity data to assess geographically where patterns exist. For example, to find or compare areas that contain more than 50% of species richness, thresholding a raster by a statistical value can be important.

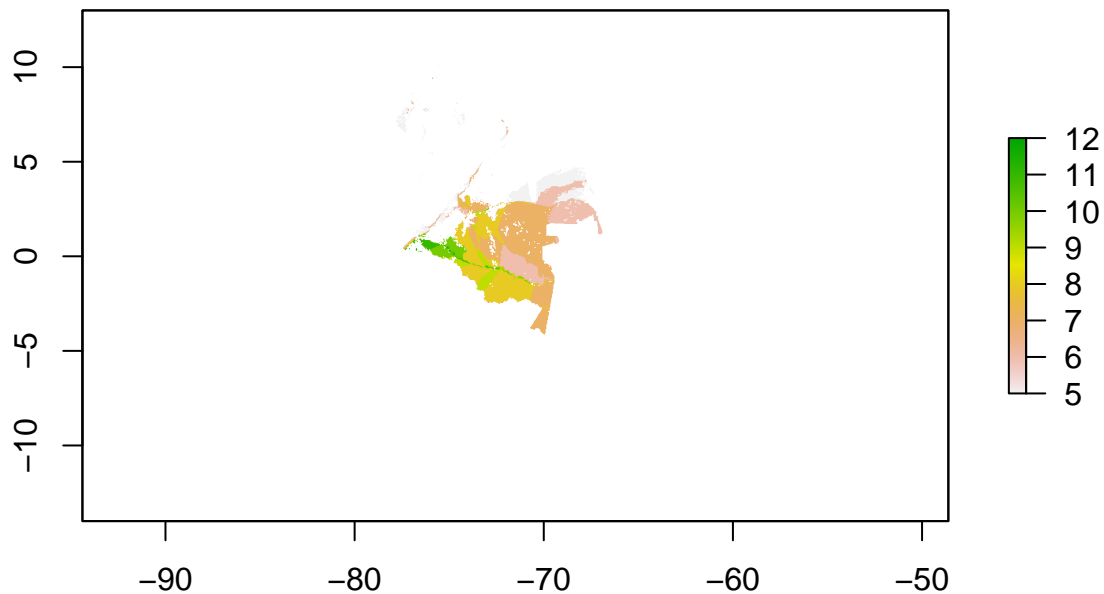

Users can then calculate the overlap of this new raster with a shapefile. For example, a user can find the proportion of 50% of species richness that is protected.

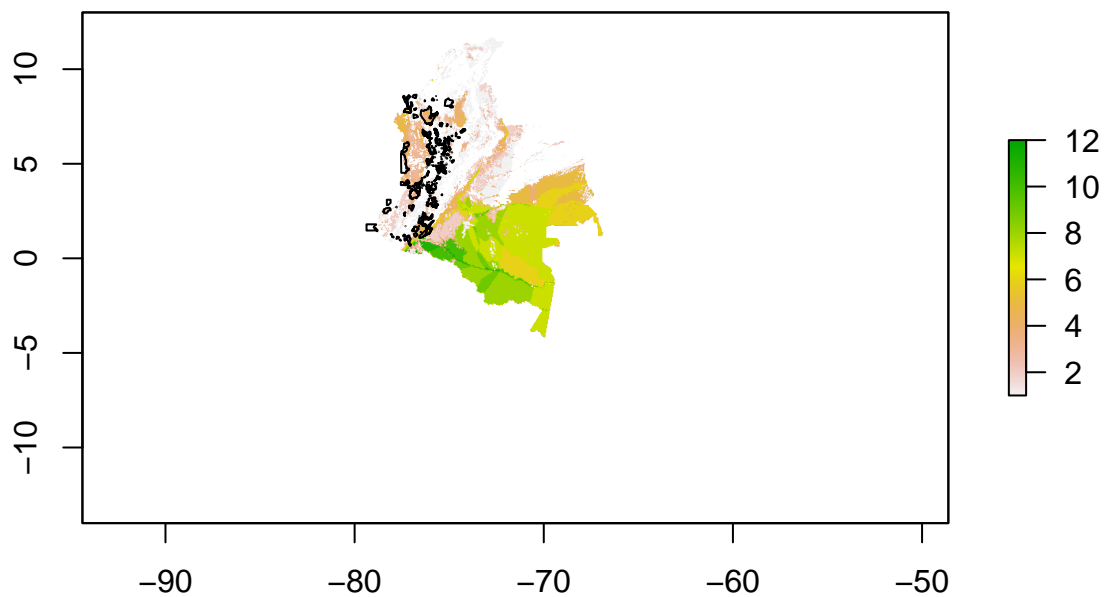
